The project aims to simultaneously promote the conservation and sustainable use of Bolivia's biodiversity, while improving the well-being of the Bolivian people, and supporting the adaptation to global climate change. We are looking for an individual who has a passion for making a difference in the lives of people around the world. Responsibilities include:

- Provide overall project leadership, management, and technical direction
- Serve as key liaison with USAID, government counterparts, and local partners to create and implement a strategic, long-term programmatic vision
- Manage and supervise project personnel, grantees and subcontractors; oversee project work planning, performance management, and strategic communications
- Ensure high-quality performance and integrity standards that comply with Chemonics and USAID policies and regulations

Qualifications:

- PhD, Masters degree, engineer, or equivalent years experience in natural resources management or related fields from an accredited university program, or a combination of professional degree-level training and a Masters degree in management, business, or public administration
