CLACSO announces the publication in English of ***Comments on a Notorious Verdict: The trial of Lula***, coordinated by the well-known Brazilian jurists Carol Proner, Gisele Cittadino, Gisele Ricobon, and João Ricardo Dornelles.

The book, whose original edition in Portuguese was launched with wide public repercussions in August of 2017, represents a valuable contribution to understanding the state of exception currently experienced in Brazil. The judicial proceedings against former President Lula are part of a conservative offensive that aspires to destitute Brazilian democracy and its main progressive political force, the Workers Party, proscribing and excluding from the electoral process its party leader and marked favorite in the presidential election of October, 2018.

Comments on a Notorious Verdict gathers more than 120 contributions from recognized personalities, intellectuals, judges, attorneys, and legal specialists, who show the ignominious, abusive, and humiliating sentence of Judge Sergio Moro, which condemned President Lula with no proof other than personal conviction. A sentence of judicial irregularities that has become one of the world's most abhorrent cases of lawfare. The use of justice as a political weapon to degrade, dishonor, and slander political adversaries, transforming them into silenced and destroyed enemies, has been one of the central components of the coup d'état that the Brazilian elites have imposed on Brazilian democracy; one of the most shameful manifestations was the destitution of President Dilma Rousseff.

With the publication of this book and a translation into Spanish that we shall present in March, CLACSO adds its categorical rejection to the process of political proscription suffered by former President Lula, demanding strict respect for the democratic state of law and the norms of due legal process.

From the office of the Council's executive secretary, we have adhered to expressions of repudiation and renouncement, such as those that have collected more than 150 thousand signatures in the manifesto, **Election without Lula is Fraud** (available in five languages) and the extremely important **Letter to the World's Jurists**. In addition, on January 24 we shall mobilize along with the international community to ensure that the shameful ruling of Judge Sergio Moro is rejected by the Federal Regional Court.

In March, 2018, during the launch of the Spanish edition of *Comentarios*, CLACSO will organize in Buenos Aires a broad international seminar on the processes of lawfare in Latin America.
