

This catalogue accompanies a Getty Center <u>exhibition</u> of the same name, which runs through September 4, 2016. Organized by the Getty Conservation Institute, the Getty Research Institute, the Dunhuang Academy, and the Dunhuang Foundation, the exhibition celebrates nearly thirty years of collaboration between the GCI and the Dunhuang Academy to conserve the Mogao Grottoes, a UNESCO World Heritage Site.

This volume includes essays by leading scholars, an illustrated portfolio on the replica caves, and comprehensive entries on all objects in the exhibition.

A Guide for Conservators, Curators, and the Curious By Roy S. Berns

Berns writes for two types of audiences: museum professionals seeking explanations for common color-related issues and students in conservation, museum studies, and art history programs. A unique feature of this book is the use of more than 200 images as its main medium of communication, employing color physics, color vision, and imaging science to produce visualizations throughout its pages. An annotated bibliography complements the main text with suggestions for further reading and more in-depth study of particular topics.





The contents of this edition of *Conservation Perspectives* are a reflection of GCI activities in China and of the evolution of policies and methods in the work of Chinese conservation professionals and organizations. Integrated with much of this work has been the GCI's participation in the development of the China Principles, a set of national guidelines for cultural heritage conservation and management that respect and reflect Chinese traditions and approaches to conservation.





AATA Update

Since the beginning of the year, *AATA Online* has added over 1,200 new abstracts of literature related to the preservation and conservation of material cultural heritage. To date, AATA Online has published nearly 137,000 records, including selected subject-specific bibliographies produced as part of GCI's own conservation and scientific research projects and collaborative projects in which the Institute is involved.
