Precisely, this article takes into consideration some of the avant-garde post-seismic reconstruction practices carried out in the seventeenth and eighteenth centuries, asthey were the cases of Cerreto Sannita, the cities of Eastern Sicily and the new urban centers created in Calabria after the earthquake of 1783.

In Rome, from October 7th to December 11th 2016, some of the monumental finds seriously damaged in Palmyra were exposed. The most interesting reconstructive event involved two busts restored in Italy thanks to 3D printing. The restoration was made one layer on top of another, in a succession of successive layers. The main feature was to realize the object in three dimensions on the basis of a software presented in Rome in the MakerFaire Rome of 2013. Currently the two busts of Palmira have returned to Syria.
